2019 TIRE PROTEST RULE

1. Protest fee is \$200.00 per tire.
2. All Hoosier DRS1350 & DRS1600 and Hoosier 21 / 55 / 1350 & 1600 must conform to the manufacturer's submitted benchmarks.
3. Submitted samples will be sent to a reputable lab for testing, the lab's findings will be the final decision there is no appeal process.
4. Any tire which fails to conform with the manufacturer's submitted benchmarks the driver will be disqualified, forfeit all prize monies and points for said event and fined, First offense driver will be fined \$300.00, second offense \$600.00, Third offense \$900.00 fines must be paid before you can compete in any event at Dixie or Rome Speedway.
5. Dixie & Rome Speedways reserves the right to hold purse monies until the tire results have been received from lab.
6. Super Late Model
Qualifying- Anyone that qualifies may protest any car that qualified.
Feature- Must be in the top 10 and on the lead lap.

- 7.** Steel Head
Qualifying- Anyone that qualifies may protest any car that qualified.
Feature- Must be in the top 10 and on the lead lap.
- 8.** Crate Late Model
Qualifying - Anyone that qualifies may protest any car that qualified.
Feature- Must be in the top 10 and on the lead lap.
- 9.** 602 Sportsman & Economy Bomber
Hot lap qualifying anyone that's in Hot laps.
Feature must be in the top 10 and on the lead lap.
